- An in-depth assurance tool to guide you through the complex process of ensuring you have the correct documented evidence and actions required to demonstrate infection prevention and control compliance against each of the 10 criterion of the *Code of practice*.
- A range of essential IPC audit tools and competency assessment tools, e.g. aseptic technique, commode and commode pan, enteral tube feeding, hand hygiene, mattress and mattress cover, personal protective equipment, pressure relieving cushion and cover, safe management of care equipment and safe management of the care environment. Also includes a comprehensive 'Standard infection control

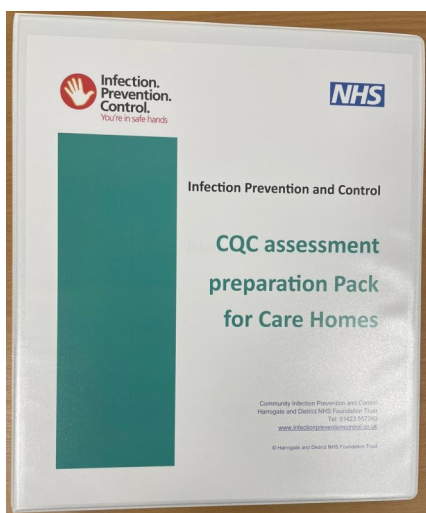
precautions Assurance: Annual IPC Audit Tool' which works in conjunction with the other IPC audit and assurance tools.

- A supply of key posters, notices, flow charts and leaflets, e.g. Hand hygiene, Bare below the elbows, Breach of hygiene, National colour coding poster for cleaning materials, Sharps/ inoculation incident procedure.
- Other IPC information, including an 'Annual statement on compliance template', 'IPC risk assessment template' and job description addendums for all staff and IPC Leads.
- Signposts to other IPC information, e.g. 'IPC Cleaning schedule and record templates'.

CQC regulation is essential to ensure that organisations are compliant with the *Code of practice* and ensure that residents receive safe and effective care.

The most important outcome of effective infection prevention and control is:

Preventing healthcare associated infection = Patient safety

Objective:

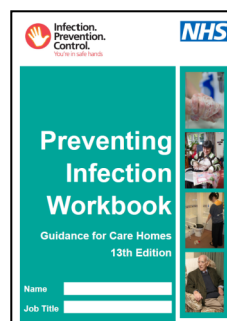

- The Workbook is kept by the member of staff as part of their portfolio of evidence of learning and can be used as a reference guide for day-to-day working

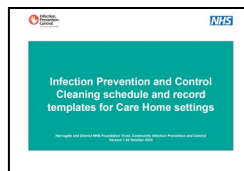

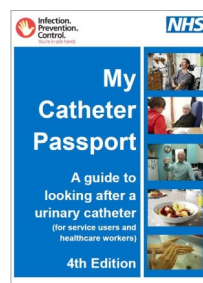

A wide selection of IPC Posters are also available. Some can be downloaded free of charge, whilst others are available to purchase.

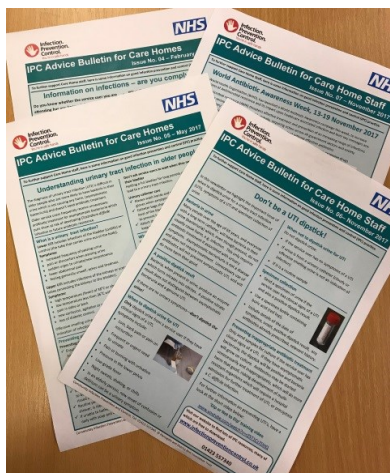

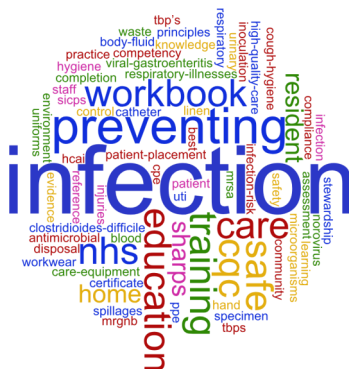
