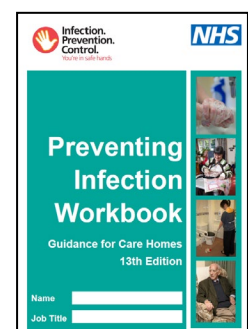
- Provides national guidance and evidence-based information.

The digital package comprises:

- Digital PDF of the 'Workbook' which allows the user to complete the 'Test your knowledge' questions at the end of each section and the Manager can complete the 'Certificate of completion' in the back of the Workbook
- Digital PDF of the 'Question sheet' which the user can complete and email to their Manager for checking rather than/or as well as completing the questions within the Workbook
- 'Answer sheet' for use by the Manager to check that the member of staff has achieved 100%
- Digital PDF of the 'Certificate of completion' for the Manager to complete and return to the member of staff rather than/or as well as completing the certificate in the back of the Workbook
